STEWARDSHIP: AWS engaged community members in stewardship action, to increase awareness of the river, foster enjoyment of nature, and motivate further stewardship of the river and to restore the health of the watershed. AWS reduced pollution caused by stormwater runoff by establishing rain gardens, Bayscapes, rain barrels, and cisterns. We engaged thousands of volunteers to remove tons of trash, recyclables and tires; plant thousands of native plants; remove acres of invasive vegetation; and restore acres of wetland habitat. AWS established a wildlife monitoring program and continued to monitor the river's water quality and investigate pollution discharges.

4b (Code:) (Expenses \$ 443,630. including grants of \$ 0.) (Revenue \$ 209,800.)

Environmental Education: AWS increased awareness, knowledge, skills, and a sense of stewardship among watershed residents to affect positive behavior changes for the health of the river. AWS engaged thousands of students in our service-learning programs, which include hands-on classroom education, a river field experience, and a river restoration project. Students raised wetland plants in their classrooms and then transplanted them into marshland; planted native plants along riparian buffers in their schoolyards, and painted and installed rain barrels on their campuses. AWS provided professional development and mentoring to teachers from DC and MD schools. AWS also trained adults in our Watershed Stewards Academy to design and implement watershed restoration projects in their neighborhoods.

4c (Code:) (Expenses \$ 265,589. including grants of \$ 0.) (Revenue \$ 85,400.)

Advocacy: AWS advocated for policies and resources that would favorably restore the Anacostia River as a swimmable and fishable river, with an emphasis on stormwater controls, containment of trash, and reduced sewage levels in the water. AWS crafted a bill to ban coal tar sealants that was unanimously passed by the Prince George's County Council in MD. We implemented strategies to generate scientific, legal, and grassroots support to expedite cleanup of toxics in the watershed. We succeeded in enacting bans on polystyrene foam in all three jurisdictions of the watershed. And, we maintained and collected data from multiple trash traps in DC, which enabled us to present compelling testimony at hearings in support of trash reduction legislation.
