## Anacostia Watershed Society starts 2017 with new leadership team and new board members

(Bladensburg, MD – January 27, 2017) – The Anacostia Watershed Society today announced three staff promotions and two Board appointments that position the organization for sustainable growth and impact in 2017 and beyond.

Jim Foster President of the Anacostia Watershed Society announced the following promotions:

- Erin Castelli, long-time leader of the organization, has been elevated to Senior Vice President and Chief Operating Officer, leading the staff in executing the organization's strategic plan;
- Emily Conrad, who has served on the Development Team since 2010, has assumed the role of Director of Development, overseeing all fundraising efforts, as well as the organization's marketing and communications program; and
- Ariel Trahan will oversee all program-related activities as Director of River Restoration Programs, integrating the education, outreach, recreation, and restoration functions to increase efficiency and impact.

In addition, at their December meeting, the Board of Directors appointed two new members: Neil S. The Board also thanked Sadara Barrow, Antoinette Sebastian, and Jack Wennersten for their years of devoted service as Board members. Robert Boone was named Founding Director Emeritus.
